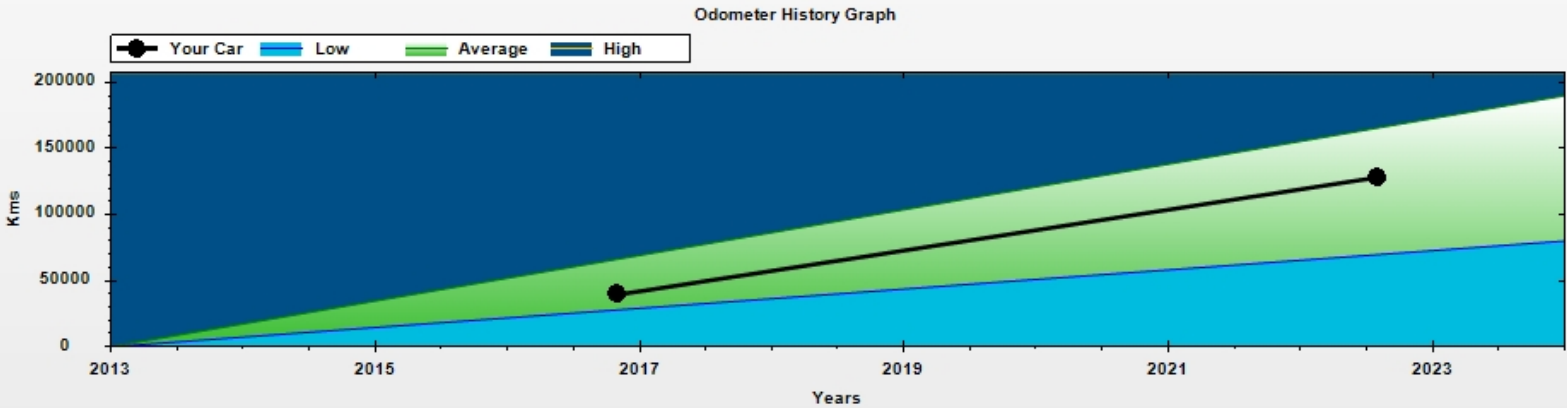

Body	A vehicle's body type.
