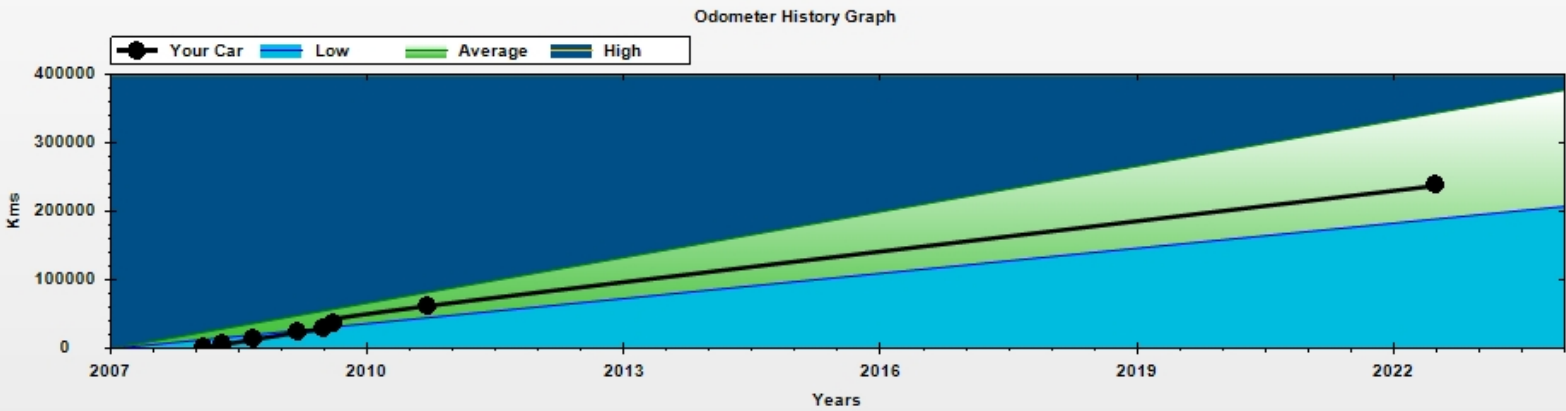

Terminology	Definition
