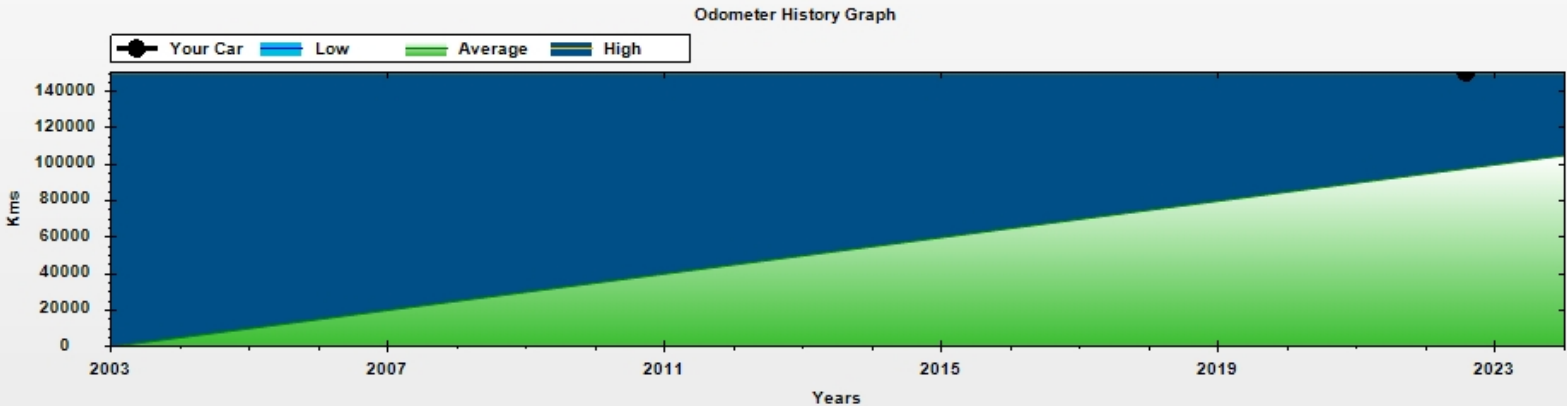

Terminology	Definition

Body	A vehicle's body type.
