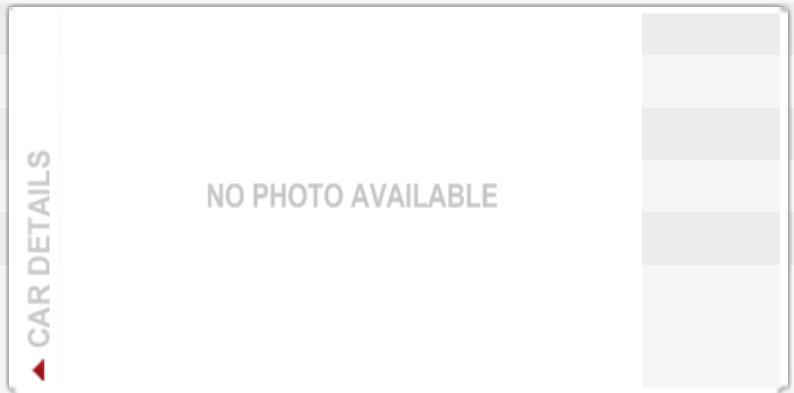

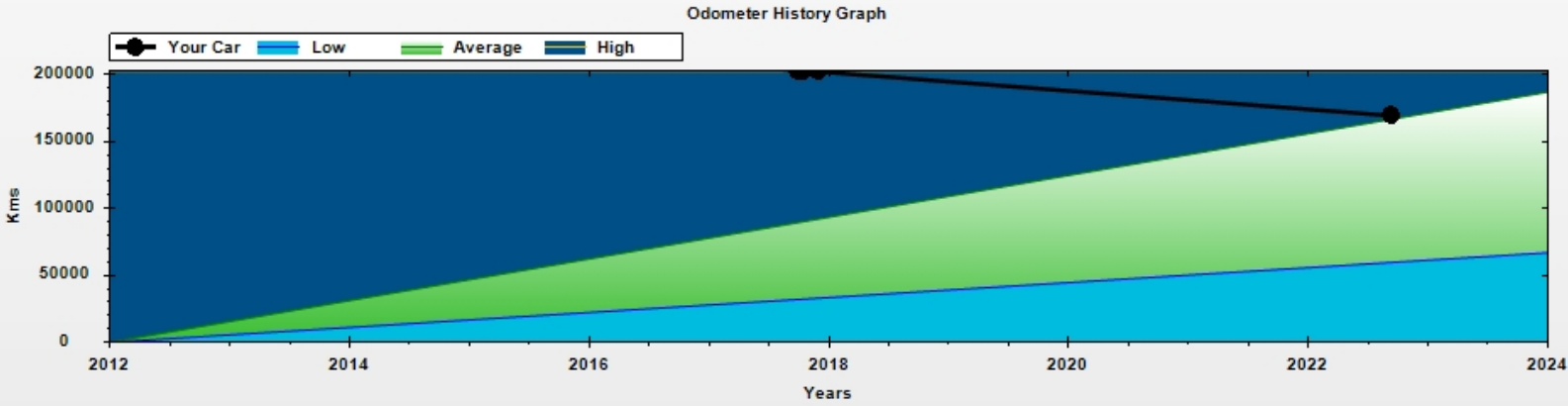

Terminology	Definition
Air Pollution Rating	The Air Pollution Rating is based on the level of air pollutant emissions allowable under the standard to which the particular vehicle has been successfully tested to for supply to the Australian market.
ANCAP Safety Rating	The Australasian New Car Assessment Program (ANCAP) gives consumers consistent information on the level of occupant protection provided by vehicles in serious front and side crashes. The score is a star rating, between 1 to 5 stars. The higher scores are awarded more stars.
Body	A vehicle's body type.
Cylinders/Rotors	Engine cylinder configuration.
Dealer Price	An indicative vehicle value for non-franchise dealer trade or wholesale transactions. Trade low must be adjusted for (Back 10 Years) kilometres and condition. Please refer to the 'Guide Condition' definition.
Dealer Trade Price	A median value achieved by a franchise dealer, e.g. Ford dealer would achieve for a Ford, (Back 10Years) for a vehicle in 'Guide Condition' and average kilometres. Please refer to the 'Guide Condition'.
